Mevlana Jalaluddin Rumi, whose life and mystical poetry provided the inspiration for the Mevlevi Sufi order, is one of the world's best-known poets.

Yet the centuries-long musical tradition cultivated by the Mevleviye remains much less known. In this deeply researched book, renowned scholar Walter Feldman traces the historical development of Mevlevi music and brings to light the remarkable musical and mystical aesthetics of the Mevlevi *ayin* – the instrumental and vocal accompaniment to the sublime ceremony of the 'Whirling' Dervishes.

- Explores the musical tradition linked to the Mevlevi ('Whirling') Dervishes and the spiritual legacy of Mevlana Jalaluddin Rumi, one of Islam's greatest mystical poets

Walter Feldman is a leading scholar of both Ottoman Turkish and Jewish music. His major publications include *Klezmer: Music, History and Memory* (Oxford, 2016) and *Music of the Ottoman Court: Makam, Composition, and the Early Ottoman Instrumental Repertoire* (Verlag für Wissenschaft und Bildung, 1996). As a lifelong musician, Feldman performs on the Ottoman tanbur and the cimbal – the traditional Klezmer dulcimer. He has held teaching positions at Princeton, the University of Pennsylvania, and New York University Abu Dhabi and is a board member of the Corpus Musicae Ottomanicae Project of the Wilhelm Westphalian University in Münster, and of the Istanbul Research Institute.

Jonas Otterbeck examines Awakening's remarkable rise and their reputation as one of the most important global enterprises producing pop music inspired by Islam. He scrutinises the ethical masculinity of Awakening's artists, alongside their personas in songs, on stage and on social media, and analyses how popular culture and the creative arts challenge Islamic (re)thinking.

The book relates the history and development of new Islamic popular music genres: in particular, pop-nashid and Islamic pop. It also examines how the emphasis on ethics in the songs and music produced by the Islamic pop industry is altering the very formulations of Islamic thought.

The study of Islam and Muslims in Europe and North America has expanded greatly in recent decades, becoming a passionately debated and divided field.

This collection critically assesses the development of the field of Islamic Studies and its place in society. Featuring contributions from anthropologists, historians and scholars of religion, each chapter contains new empirical material and discusses approaches to the study of Islam, past and present.

The book situates Islamic Studies within broader discussions of the construction of identity and its political implications in Europe and North America. The authors also address tensions between normative and non-normative approaches to the study of Islam and Muslims and consider how these might be reconciled.

His most recent monograph is *Poet and Businessman: Abd al-Aziz and the Formation of Modern Kuwait* with Gingko (May 2022).

Philip Wood is Tejpar Professor of Inter-Religious Studies at AKU-ISMC. His research focuses on Christians and Muslims in the Middle East c.500–1000, and he is particularly interested in the role of history-writing and hagiography in reflecting and asserting social boundaries. Wood is the author of *The Chronicle of Seert: Christian Historical Imagination in Late Antique Iraq* (OUP, 2013) and editor of the volume *History and Identity in the Late Antique East* (OUP, 2013). His latest monograph, *The Imam of the Christians: The World of Dionysius of Tel-Mahre c.750–850*, was published by Princeton University Press.

In the 25 years since Deniz Kandiyoti's seminal publication of *Women, Islam and the State*, the universe of action and meaning surrounding the key terms of its title has been radically transformed. There has been no comprehensive attempt, to date, to revisit the original debate or to set new terms of reference. The manner in which the state and governance were conceptualised therefore requires a radical reformulation.

This book looks at key global developments that include the effects of neo-liberal restructuring (and the demise of post-independence social contracts), contested and fragmented sovereignties, and the disarticulation of states enmeshed in a variety of external interventions (armed or otherwise). The politics of gender is explored systematically in the following case studies: Egypt, Iran, Turkey, Saudi Arabia, Afghanistan, Palestine, Iraq, Pakistan and diasporic communities in Europe and North America.

Explores the influence of centres of Islamic learning in Saudi Arabia, Iran and Egypt.

Claims abound that Saudi oil money is fuelling Salafi Islam in cultural and geographical terrains as disparate as the remote hamlets of the Swat valley in Pakistan and sprawling megacities such as Jakarta.

In a similar manner, it is often regarded as a fact that Iran and the Sunni Arab states are fighting proxy wars in foreign lands. This empirically grounded study challenges the assumptions prevalent within academic as well as policy circles about the hegemonic power of such Islamic discourses and movements and their ability to penetrate Muslim communities and societies. Through case studies of academic institutions, the volume illustrates how transmission of ideas is an extremely complex process: the outcome of such efforts depends not just on the strategies adopted by backers of those ideologies, but equally on the characteristics of the recipient communities.

In order to understand this complex interaction between global and local Islam and the plurality in outcomes, the book focuses on the workings of three universities with global outreach, whose graduating students carry the ideas acquired during their education back to their own countries, along with, in some cases, a zeal to reform their home society.

- Focuses on case studies of three of the most influential international centres of Islamic learning in contemporary times: Al-Azhar University in Egypt, International Islamic University of Medina in Saudi Arabia and Al-Mustafa University in Iran
- Traces the activities and influence of graduates in their home communities to show how ideas are transmitted between locales and how this often induces adjustments of those ideas
- Takes a comparative approach with cases from North and West Africa and Southeast Asia







Human Rights and Reformist Islam critiques traditional Islamic approaches to the question of compatibility between human rights and Islam, and argues instead for their reconciliation from the perspective of a reformist Islam. The book focuses on six controversial case studies: religious discrimination; gender discrimination; slavery; freedom of religion; punishment of apostasy; and arbitrary or harsh punishments.

Explaining the strengths of structural *ijtihad*, Mohsen Kadivar's approach is based on the rational classification of Islamic teachings as temporal or permanent on the one hand, and four criteria of being Islamic on the other: reasonableness, justice, morality and efficiency. In the book, all Qur'anic verses and *hadiths* that are problematic in relation to human rights are abrogated rationally according to these criteria. The result is a powerful, solutions-based argument founded on reformist Islam – providing a scholarly bridge between modernity and Islamic tradition in relation to human rights.

Take a front-row seat to the debate on blasphemy and apostasy in Islam.

Is it lawful to shed the blood of someone who insults the Prophet Muhammad? Does the Qur'an stipulate a worldly punishment for apostates? This book tells the gripping story of Rafiq Taqi, an Azerbaijani journalist and writer, who was condemned to death by an Iranian cleric for a blasphemous news article in 2006.

Delving into the Qur'an and Hadith – the most sacred sources for all Muslims – Mohsen Kadivar explores the subject of blasphemy and apostasy from the perspective of Shi'a jurisprudence to articulate a polarisation between secularism and extremist religious orthodoxy. Documented are a series of online exchanges, in which he debates the case with Muhammad Jawad Fazel, the son of Grand Ayatollah Fazel Lankarani who issued the fatwa pronouncing the death penalty on Taqi. While disapproving of the journalist's writings, Kadivar takes a defensive stance against vigilante murders and asks whether death for apostasy reflects the true spirit of Islam.



Explores secularism and secularisation in Arab societies since the mid-nineteenth century.

This book is a translation of Aziz al-Azmeh's seminal work *Al-'Ilmaniya min mandhur mukhtalif* that was first published in Beirut in 1992. Both celebrated and criticised for its reflections on Arab secularisation and secularism in the modern history of the Arab world, it is the only study to date to approach its subject as a set of historical changes affecting the regulation of the social, political and cultural order, and which permeated the concrete workings of society.

The author takes a comprehensive analytical perspective to show that an almost imperceptible yet real, multi-faceted and objective secularising process has been underway in the Arab world since the 1850s.

- Traces the concrete secular transformations in Muslim societies which occurred at particular times and by specific social agencies

Aziz al-Azmeh is CEU University Professor Emeritus and Distinguished Visiting Professor in the Department of History, Central European University, Vienna and Budapest. Prior to that, he taught at the University of Exeter and at the American University of Beirut, and was Visiting Professor at Columbia, Yale, Berkeley, Georgetown, ISTAC and Distinguished Visiting Professor at the Institut d'Études Politiques, Paris. He was also a long-term Fellow at the Institute for Advanced Studies, Berlin and a Fellow at the Swedish Institute for Advanced Studies, Uppsala, the Kollegium Budapest, the Kaete Hamburger Kolleg, Bochum and a Senior Fellow of the Alexander von Humboldt Foundation, University of Bonn, as well as a Resident Scholar at the Rockefeller Foundation Center for Scholars in Bellagio. Aziz al-Azmeh held the Bourse Fernand Braudel over several terms as Directeur de Recherches Associé, Maison des Sciences de l'Homme, Paris.







Georges Corm is Professor at the Institute of Political Science at Saint-Joseph University in Beirut, Lebanon. He was formerly a public sector economist and an international economic consultant. Between 1998 and 2000 he was Lebanese Minister of Finance. He has published extensively on the contemporary history of the Middle East and relations between the Arab world and the West. Bahia Shehab is a multidisciplinary artist, designer and art historian. She was included in the BBC's 100 Women list (2013), TED Senior Fellowship (2016), and a Prince Claus Award (2016). Her publications include *A Thousand Times NO: The Visual History of Lam-Alif.* She is the first Arab woman to receive the UNESCO-Sharjah Prize for Arab Culture (2016).






